

## EDITOR'S COMMENT

When it was recently announced that Galway's city and county councils were set to merge, it came as no surprise really that the news was not welcomed by the locally elected public representatives.

It's certainly no secret that the proposed merger has long been strongly resisted and opposed by Galway's city councillors and their colleagues in the county councils, who believe that both authorities are completely different and that one body cannot rule for both.

And a former mayor of the city reckons that Galway will lose out on major tourism and infrastructural funding due to the decision to amalgamate the city and county councils. Cllr Padraig Conneely has also said that the city will lose out on arts and literary benefits which would now have to be shared with the county.

The Fine Gael councillor, who was Mayor of Galway from 2008 to 2009, where he was known as 'the Maverick Mayor', voiced his anger in a recent interview with 'The City Tribune' after it was confirmed that Galway's city and county councils would amalgamate no later than 2021. Local elections scheduled for next year will still go ahead as planned.

The merger has been mooted for the past three years with several reports and committees recommending the move.

Galway's former mayor said that the funding that the city receives will be 'slashed' as it will have to be shared out with the county. The merger of the two local authorities means that the body will now have 57 elected members – 39 in the county and 18 in the city.

However, in looking at the mergers of the city and councils in Limerick and Waterford, in addition to the union of South and North Tipperary County Councils, for all intents and purposes, all it would appear have been successful without any hitches.

And even environmental watchdog An Taisce has rowed in behind the Galway Expert Advisory Group (who had recommended the merger), noting that the decline of rural Galway would be halted with the amalgamation of the city and county councils.



## 87 Mayo County Council

Mayo scored an awards treble in Croke Park earlier this year when it scooped the coveted 'Council of the Year' title and two category wins at the 12th All Ireland Community and Council Awards.

## 105 Fold Ireland

Fold Ireland has turned the sod on a new 43-unit purpose-built development for older people in Dublin 8. Scheduled to be ready for occupation in early 2019, the New Dolphin's Park site is being delivered in partnership with DCC and the Department of Housing, Planning and Local Government.

## 107 ABM Design & Build

ABM Design and Build Ltd has completed Rapid Build Social Housing projects for Dublin City Council using off-site construction techniques at sites in Finglas and Drimmagh.

## 110 Wastewater Treatment

The EU is set to take action against Ireland, citing parts of the country as non-compliant in relation to the quality of sewer/wastewater discharges to our waterways, according to Patrick Moran, Executive Area Engineer with Tipperary County Council.

## 116 Whirlpool Research

Whirlpool research at IT Sligo is set to change the way rail, flood and sewerage systems are built in the future, following the findings of a study by researchers from IT Sligo and one of Switzerland's leading universities, shedding new light on the flow patterns of whirlpools.

## 118 Cork City Council

More than €700 million is currently being invested in Cork's city centre, through a number of private and public developments, which include multi-functional sites encompassing retail, office, education, culture and tourism.

## 120 IPA Training & Education
