EDITOR'S COMMENT

Ireland's national winners of the Good Practice Awards competition – Kildare County Council and Astellas Pharma – were first-time entrants to the European biennial awards scheme.

Having both submitted practical examples of good practice in the management of OSH within the context of an aging workforce – the theme of the European Healthy Workplaces Campaign for 2016-2017, the national winners went forward to the European leg of the competition where they were judged against other national winners in Europe.

Although they have not succeeded in going forward to the final of the Good Practice Awards, which take place in Malta on 26 April, invaluable lessons have been learned along the way. In this issue of 'Health & Safety Times' we profile initiatives rolled out by both Kildare County Council and Astellas Ireland's Kerry Plant, which are now ongoing and will pave the way for future health and wellbeing programmes in each organisation.

The theme of the project as submitted by Kildare County Council – 'The Health Promotion of an Ageing Workforce' – aims to promote a healthy lifestyle for ageing employees, where emphasis has been placed on nutrition, exercise and positive mental health.

Keeping Our People Young' – the submission by Astellas Ireland's plant in Killorglin – was essentially an extension of a number of annual health and fitness projects already in place in recent years; the 'Astellathon' kicked off in 2015 followed by the '5 Star Challenge' two years ago, and now the 'Live Longer Challenge' starts in February.

Though they may not have progressed to the final in April, invaluable lessons have been learned by both camps in promoting and encouraging their employees to lead healthier lifestyles in the long term.
