In this issue of 'Health & Safety Times', Dr Majella Cosgrove, manager of the HSA's Chemicals Helpdesk, advises companies to be aware of their obligations and next year's deadlines set down within the EU REACH Regulations.

The Helpdesk is now offering advice on requirements to meet EU REACH Regulation deadlines by 31 May 2013. REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) is an EU Regulation that aims to improve the protection of human health and the environment from risks that can be posed by chemicals, while enhancing competitiveness of the EU chemicals industry.


Missing such deadlines could have a major impact on the running of a business; companies may find themselves unable to market their products or source vital chemicals, she warns.

Meanwhile, across the broad spectrum of businesses in Ireland, IBEC recently issued a new guide that aims to help companies and organisations to manage their safety liability more effectively.
